

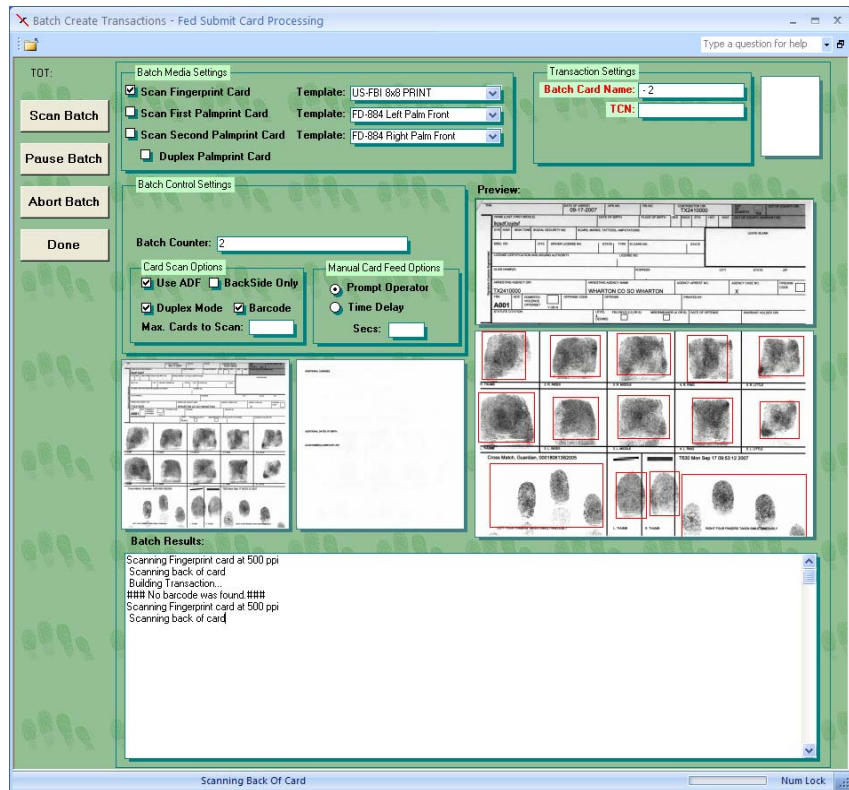
Fed Submit™ Card Processing

Overview

Mentalix's Fed Submit Card Processing solution is designed for service bureaus or large agencies that process a high volume of fingerprint cards. Using multiple flatbed scanners, fingerprint cards are scanned and converted to NIST/EBTS format. Fed Submit Card Processing provides an interface for creating electronic fingerprint files, checking the data, tracking scan statistics, and publishing the files to storage media or submitting the transactions to an AFIS. Mentalix can work with you to tailor the system to match your company's requirements.

Benefits

- Interface can be customized for specific card templates and features that match your company's workflow
- Scalable system can be used to support tens or hundreds of scan stations sharing the same database
- Additional documents and photos associated with each card can be scanned and included with EBTS file
- Specialized configuration options include: palm print card scanning, 1000 ppi fingerprint scans; storage of front and back card images, photos and documents with EBTS file; customized data entry; serial number entry; bar code support; and integration with external sources of demographic records such as criminal history databases.
- Use administrative reports to see processing and error rates for each scan station



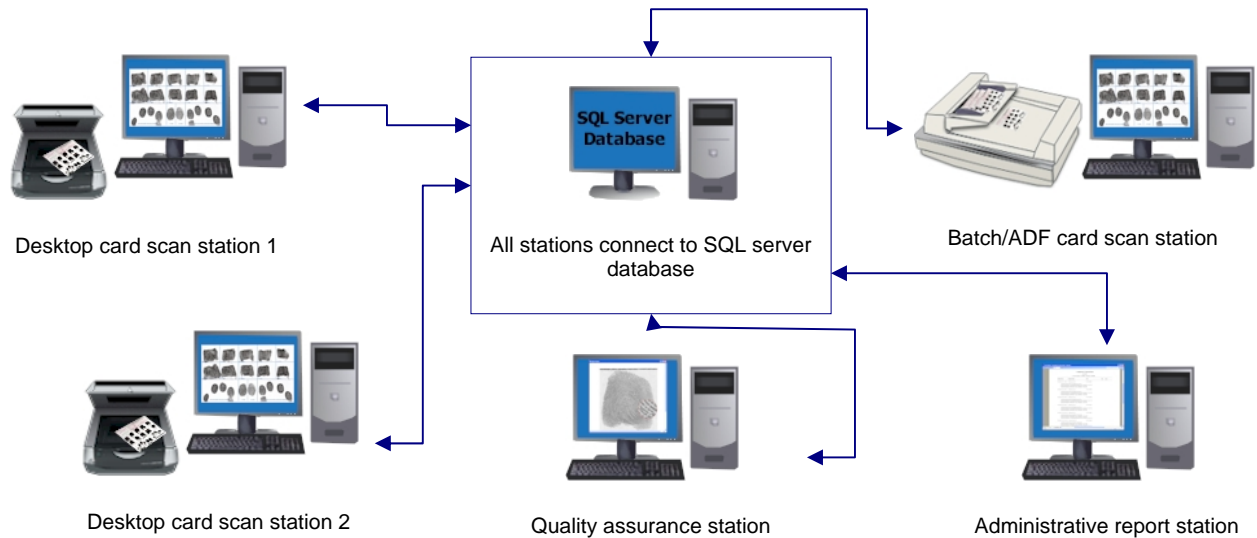
Fed Submit Card Processing saves both the front and back sides of each fingerprint card, along with photos and additional documents.

- Verification functions allow you to separate the scanning and quality assurance tasks

Pricing

Mid- to high-end range Intel (Core i5/i7 2.5 GHz, Core 2 Duo, etc.) or similar AMD processor, 4+ GB memory

Display:

- AGP or PCI-Express video card with 256 MB or more video RAM, capable of 1280 x 1024 resolution
- 20-inch or larger LCD flat-panel display. SXGA (Super Extended Graphics Array) capable.

USB 2.0 port and cable (for flatbed card scanner)

UPS power backup system

Epson Expression 1000XL flatbed scanner with automatic document feeder (ADF), connects via USB

For remote support: PC Anywhere V12.5 Host or installed LogMeIn client. Allows Mentalix support personnel, while under your supervision, to diagnose problems on your system.
