

A specialized version of Mentalix's Fed Submit (Criminal) software, Fed Submit (TX) is tailored specifically to meet the requirements for Texas DPS submissions. Widely used by Texas law enforcement agencies, Fed Submit (TX) is one of the first solutions in the state to offer transmission of encrypted fingerprint records via the Internet.


