TX DPS Soon Accepting Law Enforcement Applicants & Sex Offender Registration Submission Electronically

TXDPS recently announced that they will be permitting new, specialized transaction types for police applicants and for sex offender registration. These exciting new changes will speed up both processes with less time and effort.

Law Enforcement Applicants

The new transaction type will allow the submission of fingerprints in-house through the agency's own live scan system, making the submission process to Texas DPS efficient and nearly instantaneous. Applicant responses will be attained through the existing DPS Clearinghouse that you currently use.

Sex Offender Registration

The new transaction type now allows sex offender registration to be done digitally through the Sex Offender Registration Secure Web Site. This new process will make registration quick, secure, and allow agencies to have the most up to date information for future use.

Mentalix Fed Submit supports these new transaction types, and will be available to all customers with current maintenance with the version 3.1 software update. Note that per agency authorization is needed from TXDPS prior to use of these new capabilities.

It is important to note that **mugshot (type 10) photos** will be required for all submissions. For those without Mugshot
