

Fed Submit 4.0 Release

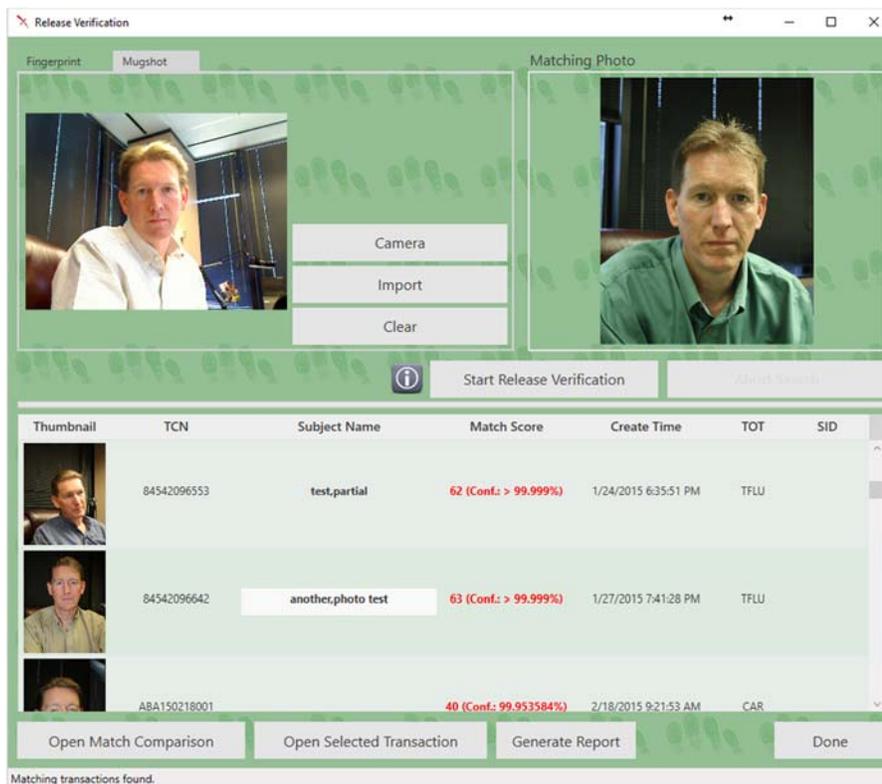

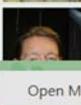

More Economical Card Conversion Option

Mentalix has had an abundant amount of customer interest in card conversion – conversion of historic paper fingerprint cards to electronic format for storage and retrieval in their Fed Submit database. Some customers have purchased additional card scan stations and are using in house or volunteer labor to complete the card conversion process. This is a very economical route, but rate of doing manual card scan - a single card at a time - is extremely limited. ***Mentalix operates a bulk card conversion center to expedite the card conversion process.*** In addition, Mentalix is now offering a joint labor option to make this opportunity more economical to our customers. Instead of Mentalix doing preparation (including barcoding) and data entry work, Mentalix now supports a card conversion flow that allows you to optionally take on these labor intensive tasks in house and at your own pace and with in-house resources. Data entry can be performed incrementally with your in-house labor resources even after card conversion is fully completed. This enables fingerprint images to be available for matching within the customer system immediately after the conversion process. The new card conversion option allows Mentalix to offer a considerably more practical and cost-efficient per card pricing model. How can I upgrade my system?

Several popular add-ons that customers have had interested in recently based on thankful availability of funding:

- **Mug Shot (Add-on):** Mug shots capture is strongly recommended for all customers. Mug shots assist in identification at all levels and there is growing importance and value in facial recognition capabilities at all levels – from FBI, to state, and even within local database.
- **Monitor upgrade:** Mentalix's new standard touch-screen industrialized monitor is a very popular option.
- **Applicant/SOR Station:** Very high interest level, check status on TX DPS official sign-off on approval along with any rules or restrictions or guidelines that TX DPS issues regarding this new capability.
- **Remote ID/Remote ID add-on units:** Remote ID enables searching not only in local database, but it enables fast-turnaround searches at both State and Federal levels. All of this is available at relatively low entry cost, especially for current Mentalix customers.
- **Release Verification/Intake Station:** Add a new workstation with a PC and 2-finger live scan capture device that dedicated to release verification. A dedicated station can eliminate the bottleneck of release verification handling from interfering with your current live scan station. The station doubles as an Intake Station that can be used pre-booking to quickly identify incoming subjects that have previously been booked in at the live scan station.
- **Latent Station:** Coming soon! The latent station allows creation of latent search transaction types. The station can import files of scanned photos and/or fingerprint images. The station integrates with the Fed Submit database and allows CSI personnel to better utilize search functions of system without tying up live scan station.
- **Other productivity improvements include:** Admin station, Juvenile station, refresher training, signature pad option, IRIS ID, printer replacement/upgrade, palm scanner upgrade, 1000 ppi palm scanner upgrade, card scan station, card scan services, archive station.

Recent Product Improvements

Updated Fingerprint Image Quality Assessment using recently released NFIQ 2.0

Mentalix has upgraded its Image Quality Assessment using the most recently technology release provided by NIST for Fingerprint Image Quality (NFIQ 2.0). According to NIST, NFIQ 2.0 provides a higher resolution quality score (in range of 0-100 according to the international biometric sample quality standard ISO/IEC 29794-1:2016 as opposed to 1-5), lower computation complexity, as well as support for quality assessment in mobile platform. The major benefit to the customer is a reduction in fingerprint recaptures because this new metric recognizes certain fingerprints to be of good quality where the older metric might have incorrectly deemed those prints to be of poor quality.
