# Mentalix Demonstrates Updated ADF R3 Feeder at IAI

Mentalix demonstrated its updated high-volume solution for certified fingerprint card scanning in early August at the Annual IAI International Forensic Education Conference in Atlanta, Georgia. The latest device improvements include a protective plexiglass containment unit fully surrounding the device to minimize sound, provide a safety barrier around moving components and a protective envelope to reduce dust and air flow interference. The result is a device that is now much more friendly and operational in a normal office environment.

The device is used within Mentalix card conversion center, but it is also is made available for purchase by integrators and end users. In addition to being the only practical feeder-based solution available for volume certified fingerprint card scanning, the device offers superior card handling care and flexibility in handling aged materials that no other device offers. Mentalix has several patents pending on the device and its unique technology.

# Updates to FSCP Card Scan Products Coming Soon!

Mentalix is working on significant re-design improvements to its FSCP card conversion and data entry software products.

Improvements will include a more flexible interface for data entry to better suit custom card conversion needs. The new improvements will make it easier to take advantage of the ADF R3 as a card conversion option.
